ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF RIVERCHASE CAPITAL, LLC

Riverchase Capital, LLC, a limited liability company organized and existing under the laws of the State of Florida (the "Company"), in order to amend its Articles of Organization in accordance with the requirements of Chapter 608, Florida Statutes, does hereby certify as follows:
