ARTICLES OF ORGANIZATION

OF

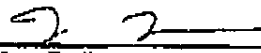
ARTICLE III - MANAGEMENT

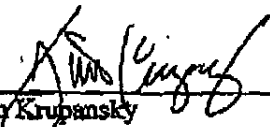
