#### ARTICLE 1 - NAME

The name of the limited liability company shall be Z4LIGHTS LLC ("Company").

#### **ARTICLE 2 - ADDRESS**

#### <u> ARTICLE 3 - EFFECTIVE DATE</u>

#### **ARTICLE 4 - DURATION**
