#### ARTICLES OF ORGANIZATION

#### HEALTH HORIZONS HOLDINGS LLC, a Florida Limited Liability Company

#### <u> ARTICLE 1- Name</u>

The name of the Limited Liability Company is HEALTH HORIZONS HOLDINGS LLC, a Florida limited liability company (the "Limited Liability Company").

#### ARTICLE II- Address

The initial principal place of business and mailing address of the Limited Liability Company is shall be 8495 S.W. 56th Street, Miami, Florida 33155.

#### ARTICLE III- Registered Agent

The management of the Limited Liability Company is reserved to members, or officers of the members, who shall be referred to as managing members. #### Article V-Duration

The existence of the Limited Liability Company shall be perpetual, unless terminated by the unanimous written agreement of all members, or by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or upon the occurrence of any event which terminated the continued membership of a member, unless the existence and business of the company is continued by the consent and agreement of the remaining members owning a majority of the membership interests, or by amendment of these Articles of Organization thereby providing for the continued

existence of the Limited Liability Company subsequent to the foregoing events.

#### Article VI-Purpose

The purpose for which the Limited Liability Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Limited Liability Company shall have all of the powers vested in a Limited Liability Company organized and existing by virtue of such laws.

#### Article VII-Capital Contribution

The total amount of cash contributed to the Limited Liability Company is One Thousand (\$1,000.00) Dollars in cash and no other property is being contributed to the Limited Liability Company.

#### Article VIII-Additional Members

Members may admit additional members upon agreement of the members owning amajority of the membership interests in the Limited Liability Company.

#### Article IX-Continuity of Business

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Elimited Liability Company, the business of the Limited Liability Company shall not be continued and the Limited Liability Company shall be dissolved unless the consent to continue of all the remaining members of the Limited Liability Company is obtained or these Articles of Organization are amended thereby providing for the continued existence of the Limited Liability Company subsequent tot he foregoing events.

#### Article X-Additional Contributions

The total additional contributions, if any, agreed to be made by all members and the times at which, or the events or happenings of which, that shall be made, are as follows: No total additional contributions have been agreed to at the date of filing of these Articles of Organization. Additional contributions, if any, will be made upon agreement of the members owning a majority of the membership interests of the Limited Liability Company.

#### Article XI-Regulations

The members shall have the power to adopt, alter, amend or repeal regulations of the limited Liability Company containing provisions for the regulation and management of the affairs of the business of the Limited Liability Company.
