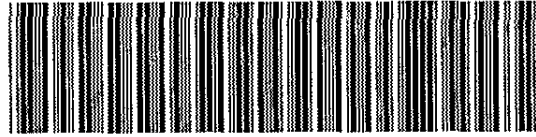



ARTICLES OF ORGANIZATION
OF
SHULA SPIRIT INVESTMENTS, LLC

1. Name. The name of the Limited Liability Company is Shula Spirit Investments, LLC (the "Company").

2. Address. The mailing address and street address of the principal office of the Company is: 16 Indian Creek Island, Surfside, Florida 33154.

3. Duration. The Company shall exist perpetually, unless sooner dissolved in accordance with the Company's operating agreement or applicable law.

4. Management. The business of the Company shall be conducted by the members. The members may appoint one or more officers to act on behalf of the Company.

5. Admission of Additional Members. Additional members may be admitted to the Company from time to time and the terms and conditions of such admissions shall require the affirmative vote of all existing members.

6. Members' Right to Continue Business. The remaining members of the Company shall have the right to continue the Company's business in the event of the death, retirement, resignation, expulsion, bankruptcy or dissolution of an member or the occurrence of any other event which would terminate the continued membership of a member, provided that all of the remaining members agree to do so in writing within 120 days after such an event occurs.

7. Registered Agent and Address. The street address of the Company's initial registered agent is 16 Indian Creek Island, Surfside, Florida 33154, and the name of its initial registered agent at such address is Donald F. Shula.
