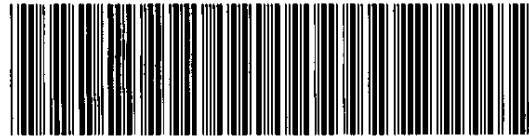

SECOND ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION
OF
FD MANATEE PARTNERS LLC

The undersigned, being the sole Member of FD Manatee Partners LLC, a Florida limited liability company (the "Company"), in accordance with the provisions of Chapter 608, Florida Statutes, hereby amends the Articles of Organization of the Company as set forth below:

1. The name of the Company is FD Manatee Partners LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State on April 19, 2007 as Document Number L07000042158 and were amended by Articles of Amendment to Articles of Organization dated May 10, 2007 and filed with the Department of State on May 15, 2007.
3. Article V. of the Company's Articles of Organization is hereby reinstated and amended to read as follows:

Article V

The Company is a Manager-managed company. The name of the Manager is Leslie A. Rubin, whose address is 4592 Ulmerton Road, Suite 100, Clearwater, FL 33762.

4. These Second Articles of Amendment shall be effective upon filing with the Florida Department of State.
5. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.
