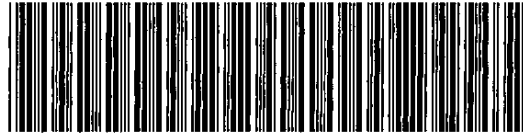



The mailing address and street address of the principal office of the company shall be 2725 Lucy Lane, Fort Pierce, Florida 34981.


ARTICLE III-REGISTERED OFFICE AND AGENT


