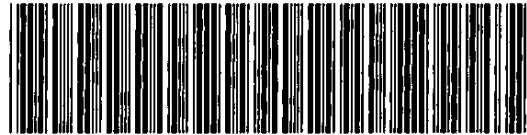

The Limited Liability Company is to be managed either the members or non-member managers and the names and addresses of the initial managers are:



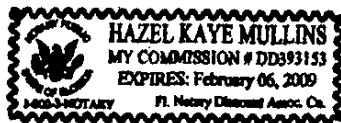


