The undersigned, desiring to form a limited liability company under and pursuant to Chapter 608 of the Florida Statutes entitled the Florida Limited Liability Company Act, (the "Act") do hereby adopt the following Articles of Organization for such company:

- 1. <u>Name</u>. The name of this company shall be Rick McDaniel's Decorative Concrete, LLC. (hereinafter referred to as the "Company").
- Duration/Continuation. Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.

- Indemnification. Except as expressly provided in the Operating Agreement, the Company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.
