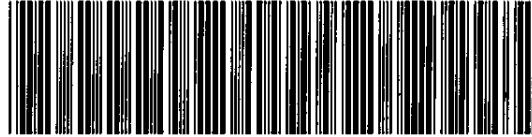



The name of the Limited Liability Company is Jean Alan Enterprises LLC.




