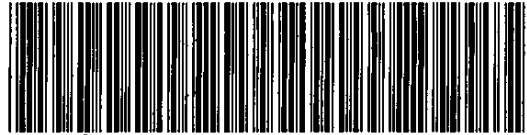

**ARTICLES OF ORGANIZATION OF
SLAW, LLC**

Article I

The name of the limited liability company ("Company") is SLAW, LLC.


Article VIII
