

We, the undersigned natural persons competent to contract, hereby organize and form a limited liability company under and pursuant to Chapter 608, Florida Statutes as follows:

ARTICLE 1.

Name of Limited Liability Company

The name of this limited liability company shall be DESTINY CHIROPRACTIC, LLC.

ARTICLE 2.

Period of Duration

The existence of the Company shall be perpetual from the date of filing the Articles of Organization with the Department of State on or about April 26, 2007 unless terminated by vote of the members.

ARTICLE 3.

Purpose

The Company is organized for the purpose of transacting any and all lawful business which limited liability companies may transact pursuant to Chapter 608, Florida Statutes.

ARTICLE 4.

Place of Business and Registered Agent

The street address of the business office of the Company is 3365 Burns Road, Palm Beach Gardens, Florida 33410; the mailing address of the business of the Company is 3178 Bermuda Road, Palm Beach Gardens, Florida 33410; and the name and address of the initial registered agent of the

Company is Richard A. Jarolem, Esq., 515 North Flagler Drive, 20th Floor, West Palm Bach, Florida 33484. The Company shall have the privilege of having offices at other places within or without the State of Florida and within or without the United States of America. The Company may, at its discretion, at any time, change the address of its place of business.

ARTICLE 5.

Additional Members

Additional members may be admitted to the Company upon such terms and conditions as shall be established by a majority in interest of the then-existing members.

ARTICLE 6.

Continuation of Business

The remaining members of the Company shall have the right to continue the business of the Company on the death, retirement, resignation, expulsion, bankruptcy or dissolution of any member or upon the occurrence of any other event which terminates the continued membership of a member in the Company.

ARTICLE 7.

Management

Management of the Company is reserved to Terri D. Bonner, the Manager, who shall serve as the manager of this Company until such time as another manager is designated in accordance with the Operating Agreement of the Company. Terri D. ARTICLE 8.

Indemnification of Members and Manager

Except in the case of gross negligence or willful or wanton behavior, the Company shall indemnify and save harmless every manager and member of the Company from all costs and expense incurred by him, her or it in connection with the defense of any action, suit or proceeding, whether

civil or criminal, in which he, she or it is made a party as a result of having been a member of or manager of this Company.

ARTICLE 9.

Substitution of Members


The interest of the initial members of the Company may be transferred or assigned to third parties who shall be successor members in their place and stead.


