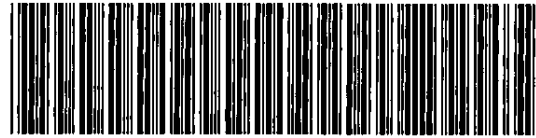

ARTICLE IV




