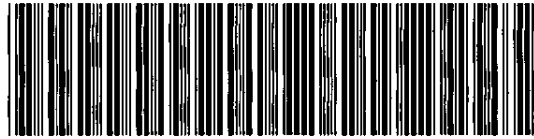

## ARTICLE VI - MANAGEMENT


