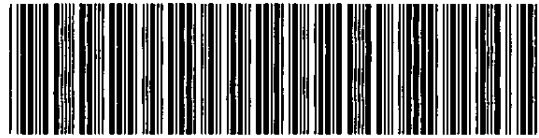

All the remaining property and assets of Advanced Energy have been distributed among its members in accordance with their respective rights and interests.



There are no lawsuits pending against Advanced Energy in any court.


