Amendment

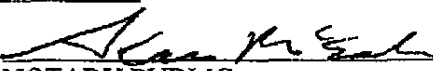
These Articles of Organization may be amended or repealed by the consent of a majority in interest of the members, or as may otherwise be provided by law.
