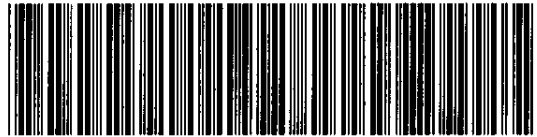

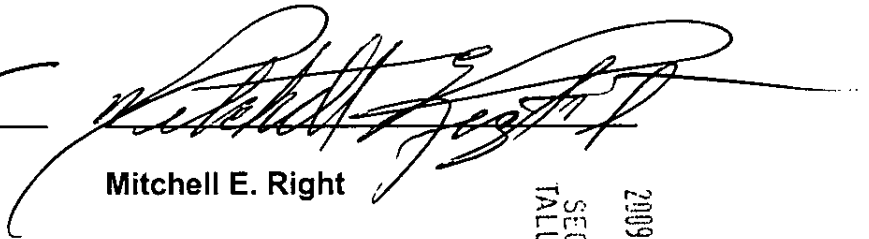
A FLORIDA LIMITED LIABILITY COMPANY
