1. The Articles of Organization of the Organization are hereby amended by deleting the present form of Article I, in its entirety and by substituting, in lieu thereof, the following:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is Automotive Processing Solutions, LLC (the "Company"). The Company's initial mailing and street address is 400 N.
