The name of the limited liability company is: Investment Associates Realty, LLC.

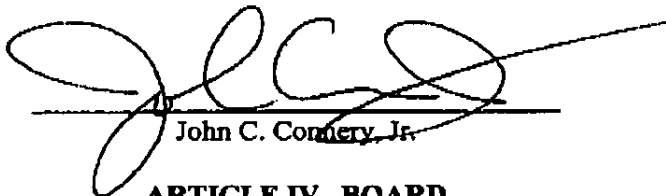
**ARTICLE II. ADDRESS**
