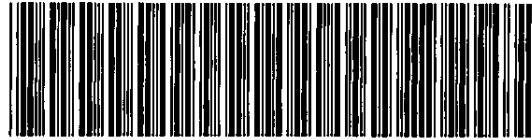

ARTICLES OF ORGANIZATION
OF
DAIRY DECISIONS CONSULTING, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Act, does hereby adopt the following Articles of Organization.

ARTICLE 1.0

The name of the Limited Liability Company shall be Dairy Decisions Consulting, LLC.

ARTICLE 2.0

The period of its duration may not exceed 40 years from the date of filing with the Department of State.

ARTICLE 3.0

The primary purpose for which the Limited Liability Company is organized is to provide consulting services to dairies and other agricultural entities. The company may also engage in any legal business or investment activity as the Managers may from time to time determine.

ARTICLE 4.0

ARTICLE 5.0

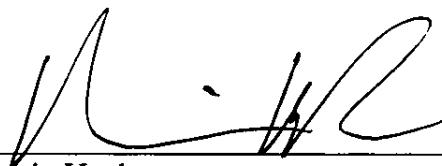
ARTICLE 9.0

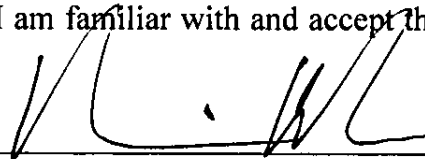
**CERTIFICATE OF DESIGNATION OF
