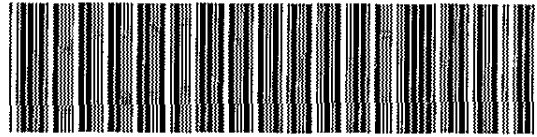

The Limited Liability Company is to be managed by one or more members and is therefore, a member-managed company. The names and addresses of the Managing Members are as follows:

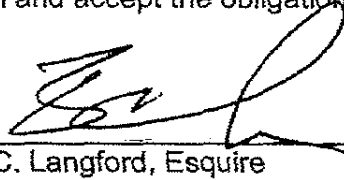

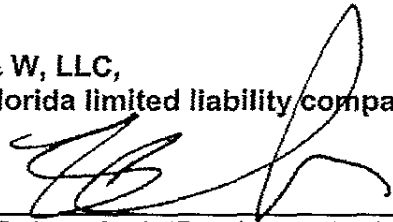
