ARTICLES OF ORGANIZATION OF C REAL ESTATE PROPERTIES LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization:

ARTICLE I - NAME

The name of the limited liability company shall be C Real Estate Properties ("Company").

ARTICLE II - ADDRESS


