# ARTICLES OF ORGANIZATION OF SCWAAB PROPERITES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization:

### ARTICLE I - NAME

The name of the limited liability company shall be SCWAAB PROPERTIES, LLC ("Company").

### **ARTICLE II - ADDRESS**

A member may transfer his or her interest in the Company as set forth in the Operating Agreement of the Company.

# ARTICLE VI - MEMBERS' RIGHT TO CONTINUE BUSINESS

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

### ARTICLE VII - MANAGEMENT

The Company shall be managed by one or more managers in accordance with Operating Agreement adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
