ARTICLE VI- ADDITIONAL CAPITAL CONTRIBUTION

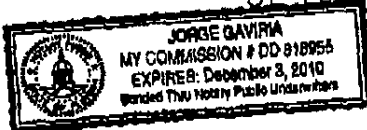
