**AMENDED AND RESTATED ARTICLES OF ORGANIZATION**  
**OF**  
**DDKP HOLDINGS, LLC**

Pursuant to Chapter 608 of the Florida Statutes, the undersigned member of DDKP HOLDINGS, LLC, hereby amends and restates the Articles of Organization originally filed with the Secretary of State on May 1, 2007, by adopting for the limited liability company the following Amended and Restated Articles of Organization which have been duly executed and filed under Section 608.411 of the Florida Statutes.

**ARTICLE I - Name**

The name of the limited liability company is: DDKP HOLDINGS, LLC (hereinafter the "Company").

**ARTICLE II - Address**

**ARTICLE III - Duration and Purpose**

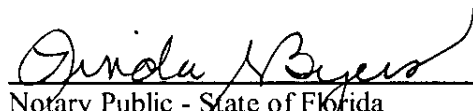

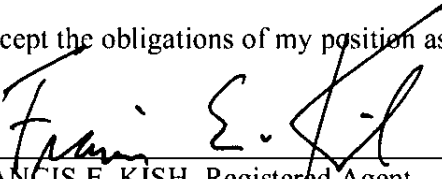
