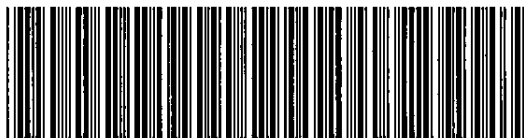


ARTICLE VI
