**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
ORLANDO MERCHANDISE MART, L.C.**

Pursuant to the provisions of Section 608.411 of the Florida Limited Liability Company Act, the undersigned limited liability company adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is ORLANDO MERCHANDISE MART, L.C. (the "**Company**").

3. The Amendments to the Articles of Organization set forth below were adopted by all of the Members of the Company.


