## ARTICLES OF ORGANIZATION OF WOMBEAT, LLC

- 1. <u>Name.</u> The name of this limited liability company is **WOMbeat, LLC**, a Florida limited liability company (the "<u>Company</u>"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
