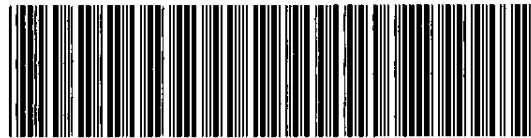



We hope this is sufficient to complete the name change and is acceptable to your system.



ARTICLE I - NAME


