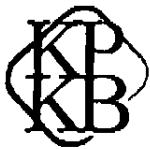

ARTICLES OF ORGANIZATION**OF****ALLIED TOWING, LLC**

The undersigned, for the purpose of forming a limited liability company under the laws of Florida, hereby adopts the following Articles of Organization:

ARTICLE I - NAME
