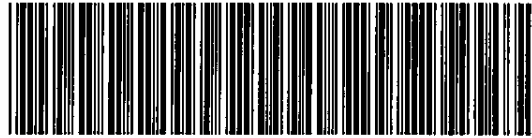



**ARTICLES OF ORGANIZATION
OF
DIALOGUE CIRCLE, LLC**

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

**ARTICLE I
NAME OF COMPANY**

The name of the limited liability company is Dialogue Circle, LLC (the "Company").

**ARTICLE II
PERIOD OF DURATION**

The Company shall terminate on December 31, 2107.


