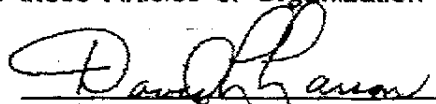

Initial Members

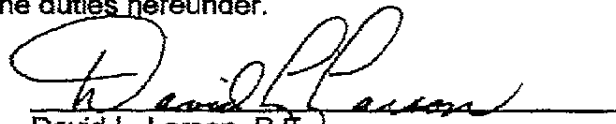
David L. Larson, P.E. shall own 70 Membership Interest Units of the Company. Margot Palmer shall own 30 Membership Interest Units of the Company.
