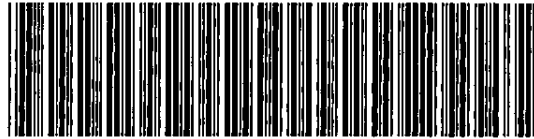



of

ARTICLE 1
NAME
