ARTICLES OF ORGANIZATION

OF

CITRUS CONTRACTING, LLC

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

ARTICLE I – NAME

The name of the limited liability company is CITRUS CONTRACTING, LLC (hereinafter referred to as the "Company").

ARTICLE II – DURATION

Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.

ARTICLE III - PURPOSE

The purpose for which the Company is organized is to engage in installation of underground utilities and any and all other business and activities permitted by the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

ARTICLE IV - ADDRESS OF BUSINESS

The mailing address for the Company is 9699 East Gospel Island Drive, Inverness, Florida 34450, and the street address of the place of business for the Company is the same. These addresses may be changed from time to time as provided in the Operating Agreement.

ARTICLE V – REGISTERED AGENT

<u>ARTICLE VII – MEMBERS</u>

The Company shall have at least one member and may admit additional members on the prior unanimous written agreement of the then-existing members, or as otherwise provided in the Operating Agreement.

ARTICLE VIII – CONTINUITY OF BUSINESS

The members, at a meeting of the members held not less than annually, shall designate the managers, who may also be members. The initial managers, who shall serve until the first annual meeting of the members or until their successors are elected and qualify shall be as follows:

ARTICLE X – INDEMNIFICATION

Except as expressly provided in the Operating Agreement, the Company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.
