The Company is a manager-managed company.

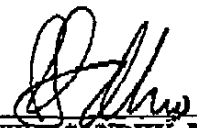
Article 9.

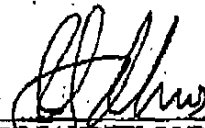
