However, the Articles of Amendment to Articles of Organization we sent to you was supposed to be for H & N PRIMA AROSO, LLC (Document No. L07000049155), *not* H & N 669 PRIMA AROSO, LLC, which doesn't even exist.

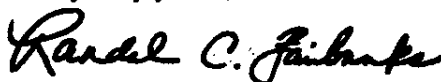

ARTICLES OF ORGANIZATION OF
H & N PRIMA AROSO, LLC**
