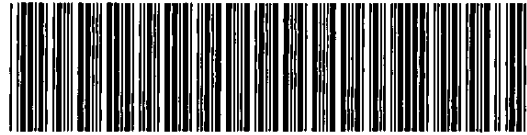

**ARTICLES OF ORGANIZATION OF
COOKED TO ORDER, LLC**

Article I

The name of the limited liability company ("Company") is COOKED TO ORDER, LLC.

Article II

The mailing and street address of the Company's principal office is 113 Heron Point Way, DeLand, Florida 32724. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.

Article III

The period of duration for the Company is perpetual.

Article IV

The name of the Company's initial registered agent in Florida is Kirk T. Bauer. The address of the Company's registered office in Florida is 223 S. Woodland Boulevard, DeLand, Florida 32720.

Article V

The Company is to be managed by the Member. The Initial Member of the Company is:

Article VI

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or


