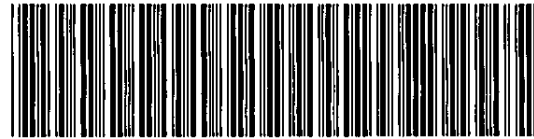

**ARTICLE 1 - NAME**

The name of the limited liability company shall be **FLORIDA MORTGAGE NETWORK, LLC**, ("Company").

**ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 1892 Northeast Jensen Beach Boulevard, Jensen Beach, Florida 34957 and the mailing address shall be the same.

**ARTICLE 3 - EFFECTIVE DATE**

whose mailing addresses shall be the same as the principal office of the Company.




