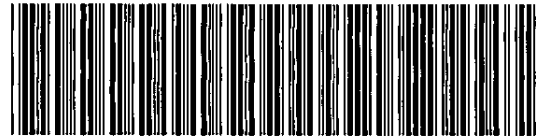

ARTICLE 1 - NAME

The name of the limited liability company shall be **JB RECRUITING, LLC**, ("Company").

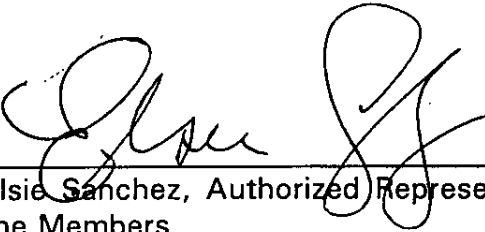

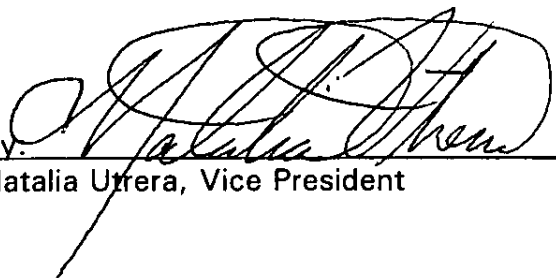
