ARTICLES OF ORGANIZATION

OF

ABOUT TIME PARTNERS, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for of the State of Florida does set in the purpose of forming a limited liability company under the laws of the State of Florida does forth the following:

#### ARTICLE I - Name
