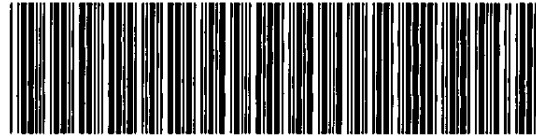

Transfer or pledge of a member's interest may not be made except upon written consent of all members.


ARTICLE VI

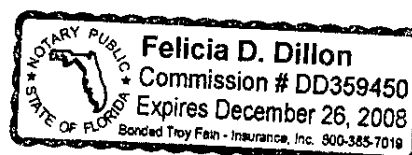
