**ARTICLES OF ORGANIZATION  
OF  
MUZAFFAR A. CHAUDHRY, PLLC**

The undersigned natural person, who is licensed and otherwise legally authorized to practice Dentistry in the State of Florida, for the purpose of forming a limited liability company in accordance with the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**Name.** The name of the limited liability company shall be Muzaffar A. Chaudhry, PLLC ("Company").

**ARTICLE II**

**Purpose.** The purposes for which the Company is formed are:

- a. To engage in the practice of dentistry as a professional limited liability company and to own and operate a dental office for the purposes of providing dental care and treatment.
- b. To promote dental and scientific research and knowledge; to furnish related laboratory and clinical services; and to own real and personal property, enter into contracts, and engage in any lawful business necessary for the rendering of such professional services.
- c. To do everything necessary, proper, or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act incidental thereto which is not forbidden by the laws of the State of Florida or by the provisions of these Articles of Organization or the operating agreement.

The professional services of the Company shall be carried out only through its members, officers, employees, and agents, each of whom is duly licensed or otherwise legally qualified to render such professional services in the State of Florida.

**ARTICLE III**

**Address.** The mailing address and street address of the principal office of the Company shall be 2413 Parkwood Drive, Panama City, Florida 32405.

ARTICLE IV

Duration. The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the operating agreement of the Company.

ARTICLE V

Initial Registered Office and Agent. The street address of the initial registered office of the Company is 111 North Orange Avenue, Orlando, Florida 32801 and the name of the initial registered agent of the Company at that address is NISHAD A. KHAN.

ARTICLE VI

Management. The Company shall be managed by a manager or managers in accordance with an operating agreement adopted by the members for the management of the business and affairs of the Company. The operating agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
