ARTICLE D: The Articles of Organization are amended such that the same may reflect as follows:

Each Member's interest in ETREND MEDIA GROUP, LLC (the "Company") (including such Member's interest, if any, in the capital, income, gains, losses, deductions and expenses of the Company and the right to vote, if any, on certain Company matters) shall be represented by "Units" (each, individually a "Unit," and any number of Units, including fractions thereof, "Units").

At the time of the present Amendments, the Units are comprised of 100 Common Units with voting rights, and are held among the Members in the following manner:

Pablo Palatnik: 70 Units ⁻ Brian Nelson: 30 Units

The ownership by a Member of Units entitles such Member to allocations of profits and losses and other items and distributions of cash and other property in a pro-rata basis, in accordance with such Member's percentage share of outstanding Units.
