ARTICLES OF ORGANIZATION

SECRETER IN BUILT The undersigned, for the purpose of forming a limited liability company under the Flork Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes and files the following Articles of Organization.

ARTICLE I -- NAME
