**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
AARON A. FARMER, P.L.**

The undersigned, acting as an authorized representative of a Member of AARON A. FARMER, P.L. (the "Company"), a Florida professional limited liability company formed under the Florida Professional Service Corporation and Liability Company Act, F.S. Chapter 621, whose Articles of Organization were originally filed with the Florida Department of State on May 14, 2007, and assigned charter number L07000051154, submits the following Amended and Restated Articles of Organization of the Company as adopted by its Member:

ARTICLE I -- NAME

The name of the limited liability company is FARMER & HINSON, PLLC.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The mailing address of the Company is 999 Vanderbilt Beach Road, Suite 606, Naples, FL 34108. The street address of the principal office is 999 Vanderbilt Beach Road, Suite 606, Naples, FL 34108.

ARTICLE III -- REGISTERED AGENT AND REGISTERED

The name and Florida street address of the registered agent of the Company Aaron A. Farmer, Esq. at 999 Vanderbilt Beach Road, Suite 606, Naples, FL 34108.

ARTICLE IV-- PURPOSE

The general purposes for which this Company is organized shall be to render legal services to the general public, and to do all things in connection therewith that are customarily performed by licensed attorneys under the laws of the State of Florida. In furtherance of its corporate purposes, the Company shall have all of the general and specific powers and rights granted to and conferred on a limited liability company by the Professional Service Corporation and Limited Liability Company Act.

ARTICLE V-- LIMITATION ON MEMBERSHIP

No one other than an individual who is duly licensed or legally authorized to render licensed legal services in the State of Florida or an organization described in Section 621.051 of the Florida Professional Service Corporation and Limited Liability Company Act may become a member of the Company. No member of the Company shall enter into an agreement vesting another person with the authority to exercise the voting power of any membership interest in the Company. Any member who becomes legally disqualified to render legal services shall sever all employment with and financial interest in the Company. No Member of the Company may sell or transfer his stock in the Company, except to another individual or an organization

eligible to become a Member of the Company.

ARTICLE VI - MANAGEMENT

The Company shall be managed by one or more manager(s) and is, therefore, a manager-managed company. The names and the addresses of the person currently serving manager of the Company are:

ARTICLE VII - CAPITAL STRUCTURE

The Company shall have a total of One Hundred Thousand (100,000) units of membership interest, of which Ten Thousand (10,000) of the total units in the Company shall be designated as Class A Voting units, and Ninety Thousand (90,000) of the total units shall be designated as Class B Non-Voting units. Only Members holding Class A units shall have the right to vote, consent, elect, and/or approve any matter submitted to the Members and Members holding Class B units shall not have any such rights, except as may be required by the Company's Operating Agreement, as amended from time to time.

ARTICLE VIII- OPERATING AGREEMENT

Any Operating Agreement (as defined in section 608.402(24) of the Florida Limited Liability Company Act), relating to the Company, must be in writing and signed by all of the members and must comply with all of the requirements of the Act.

These Amended and Restated Articles of Organization are being filed pursuant to Section 608.411 of the Florida Statutes and have been duly executed by the undersigned authorized representative of a Member of the Company on this 9th day of February, 2010.


