ARTICLE I. NAME

The name of the Limited Liability Company ("Company") **RONALD E. LONG, L.L.C.**

ARTICLE II. PURPOSE

ARTICLE VIII. ADMISSION OF NEW MEMBERS




ARTICLE IX. MEMBERS RIGHT TO CONTINUE BUSINESS

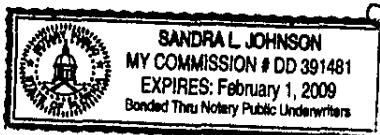




