The undersigned intends to form and create a Limited Liability Company pursuant to the Statutes of the State of Florida, and therefore does hereby state and certify the following:

1. The name of the Limited Liability Company shall be:

Next Step Flooring, Limited Liability Company.

- 2. The registered office of the company is located at 636 East Tropical Trace, Jacksonville, St. Johns County, State of Florida, 32259. Its registered agent for service of process is Stephanie S. Shamlaty, located at the aforementioned address.
- 3. The principal place of business of the company is located at 636 East Tropical Trace, Jacksonville, St. Johns County, State of Florida, 32259.
- 4. The purpose for which the company is formed is to engage in any lawful acts or activities for which limited liability companies may be formed under laws of the State of Florida;
- 5. The company shall begin operations on May 1, 2007 and have a duration of thirty (30) years, after which it shall dissolve.

6. Indemnification.

a. The termination of any action, suit, or proceeding by judgment, order, settlement, conviction, or plea of nolo contendere, or its equivalent shall not, in and of itself, create a presumption that the person did not act in good faith and in a manner which he or she reasonably believed to be in,

- b.
