2. The following amendment to the Articles of Organization of the Company to change the name of the Company was adopted by the Company:

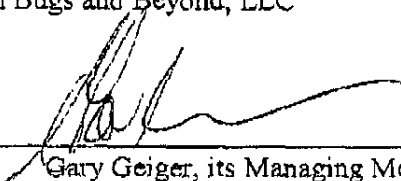
Article I of the Articles of Organization of Bed Bugs and Beyond, LLC is hereby amended in its entirety to now read as follows:

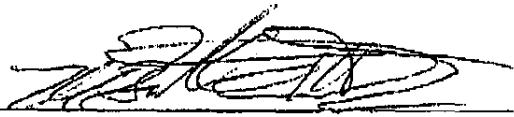
"ARTICLE I

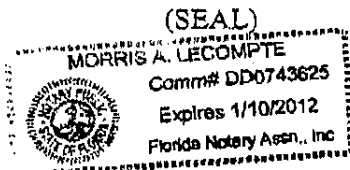

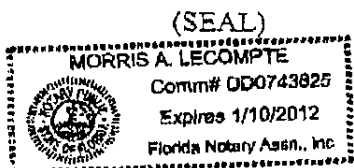
