ARTICLES OF ORGANIZATION

OF

KATHERINE'S BAY, LLC

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

<u>ARTICLE I – NAME</u>

The name of the limited liability company is **KATHERINE'S BAY**, **LLC** (hereinafter referred to as the "Company").

<u>ARTICLE II – DURATION</u>

Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.

ARTICLE III - PURPOSE
