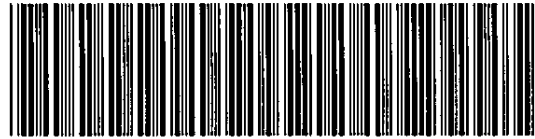

ARTICLE I

NAME

The name of this limited liability company (the "Company") shall be **CHAMPIONSHIP EVENTS OF CENTRAL FLORIDA, LLC** and its mailing address is 201 Flame Ave., Maitland, Florida 32751, and its principal place of business is 201 Flame Ave., Maitland, Florida 32751.

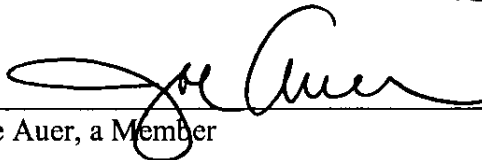
time to time without amendment of these articles of organization.

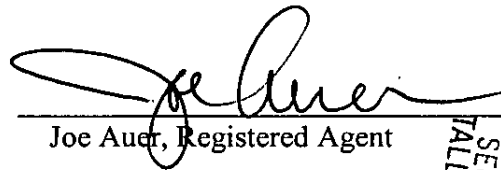
